

Mountain Province State Polytechnic College (MPSPC) has made significant advances in institutional governance, corresponding with Republic Act No. 10583, which officially converted it into the Mountain Province State University. The Board of Trustees, including locally elected representatives and private sector members, plays a crucial role in ensuring effective governance and fiscal oversight, fostering transparency and adherence to legal and ethical standards.

Recognizing the importance of student engagement and autonomy, MPSPC actively supports the formation of student organizations, promoting cooperation and growth within the student body. This inclusive approach enhances the college experience

and strengthens ties between students and the administration. The Supreme Student Government is active in its role in promoting the rights and welfare of students in the campuses.

In fostering innovation and employability, MPSPC maintains strong linkages between higher education institutions (HEIs) and the private private sector. With sector representation on the governing board, the college aligns with CHED Memorandum Order Number 7, series of 2022, contributing to strategic planning and decision-making. This collaboration enhances instructional methodologies and ensures relevance in the ever-evolving landscape of higher education.





The MPSPC Board of Trustees, emphasizing participatory stakeholder engagement, strives for a coordinated higher education system, effective governance, and academic freedom protection. This collaborative engagement is further reinforced through the integration of Cordillera 101 into the General Education Curriculum, as approved by Resolution No. 101, 2022.

Dedicated to producing morally upright graduates, MPSPC addresses issues such as corruption and bribery through a well-defined student code of conduct. The college's stringent stance on nepotism and conflicts of interest, as outlined in its personnel handbook, demonstrates a commitment to maintaining high ethical standards among employees.

Believing in the efficacy of research, MPSPC encourages researchers to align with the college's R&D priorities, promoting horizontal learning and expertise development. This research freedom contributes to SDG 16 on peace, justice, and strong institutions by empowering the researchers with knowledge and understanding of cultural, economic, and political dynamics, and contributes to the development of effective policies.

As a government institution, MPSPC ensures transparency through its official website's Transparency Seal. This initiative, mandated by Section 93, promotes accountability, encourages civil service engagement, and invites public participation in governance.

The College also has representations in various technical working groups and councils such as the Provincial Disaster Risk Reduction and Management Council, the Committee on Indigenous Peoples Concerns under the Regional Development Council, the Technical Working Group of the Climate Filed School, the Technical Working Group for the Data Privacy of the CorCAARRD, the Research Management Council of the CRHRDC, among others. The membership and participation of MPSPC faculty and personnel in these groups and committees are instrumental in the crafting of policies and programs that help in the implementation of projects and programs of the organizations concerned.


















In fulfilling its mandate for extension work, MPSPC's Extension Unit serves as a community arm, providing guidance and assistance to departments. The college imparts technical skills to policymakers and lawmakers, exemplified by training workshops on resolution-making and project proposal development.

The College is also involved in collaborative research with government for policy development. An example of this is the Citizen Satisfaction Index Survey conducted for the Bauko Local Government Unit which exemplifies MPSPC's community engagement. Survey results informed policy formulation, with recommendations for prioritizing public works, infrastructure, and economic promotion.



Promoting peace and order, MPSPC maintains a neutral space for students from diverse cultural backgrounds, earning the designation of a 'Peace Zone.' Campaigns on public safety, especially during tribal conflicts, reflect the college's commitment to promoting human rights and promoting a conducive learning environment.

In a tracer study for the School Year 2020 graduates, the Alumni Relations and Job Placement Office tracked employment outcomes, revealing that 52% secured permanent positions in law enforcement and government agencies. This employment success evidences MPSPC's goal of producing graduates with employable skills.







These initiatives undertaken by Mountain Province State Polytechnic College espouse the principles of SDG 16 on justice, peace, and strong institutions. From effective governance to community engagement, the college continuously strives to foster a positive impact on its students, stakeholders, and the broader community.
