

CONTRACT AGREEMENT

THIS AGREEMENT, executed this ______ day of ______ 2023 between MOUNTAIN PROVINCE STATE POLYTECHNIC COLLEGE (hereinafter called the "Entity") and J.D. JR. GALUTAN BUILDERS (hereinafter called the "Contractor").

WHEREAS, the MOUNTAIN PROVINCE STATE POLYTECHNIC COLLEGE is desirous that J.D. JR. GALUTAN BUILDERS executes the contract "REPAIR OF RESTROOMS AT THE FIRST FLOOR OF NEW ACADEMIC BUILDING" (hereinafter called "the Works").

WHEREAS, the MOUNTAIN PROVINCE STATE POLYTECHNIC COLLEGE has accepted the Bid amounting to ONE MILLION FIFTY-ONE THOUSAND NINE HUNDRED NINETY-EIGHT PESOS AND SEVENTY-TWO CENTAVOS (Php1,051,998.72) by the Contractor for the execution and completion of such Works and including the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - **b.** Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the MOUNTAIN PROVINCE STATE POLYTECHNIC COLLEGE through its BIDS AND AWARDS COMMITTEE's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning



bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of ONE MILLION FIFTY-ONE THOUSAND NINE HUNDRED NINETY-EIGHT PESOS AND SEVENTY-TWO CENTAVOS (Php1,051,998.72) or such other sums as may be ascertained, J.D. JR. GALUTAN BUILDERS agrees to execute the contract "REPAIR OF RESTROOMS AT THE FIRST FLOOR OF NEW ACADEMIC BUILDING" in accordance with his/her/its Bid.
- 4. The **MOUNTAIN PROVINCE STATE POLYTECHNIC COLLEGE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
