



## CONTRACT OF AGREEMENT

**THIS AGREEMENT** made on the 21<sup>st</sup> day of DECEMBER 2023 between **MOUNTAIN PROVINCE STATE POLYTECHNIC COLLEGE** (hereinafter called the "Entity") and **BALBALIN ENGINEERING AND CONSTRUCTION** (hereinafter called the "Supplier").

**WHEREAS**, the **MOUNTAIN PROVINCE STATE POLYTECHNIC COLLEGE** invited Bids for certain goods and ancillary services, particularly **IMPROVEMENT OF COFFEE TRAINING CENTER** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO MILLION FIVE HUNDRED NINETY EIGHT THOUSAND TWO HUNDRED NINETY-FIVE PESOS AND FIFTY FIVE CENTAVOS (P2,598,295.55)** (hereinafter called "the Contract Price").

### **NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:

- i. Philippine Bidding Documents (PBDs);
  - i. Schedule of Requirements;
  - ii. Technical Specifications;
  - iii. General and Special Conditions of Contract; and
  - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**



3. In consideration for the sum of **TWO MILLION FIVE HUNDRED NINETY EIGHT THOUSAND TWO HUNDRED NINETY-FIVE PESOS AND FIFTY FIVE CENTAVOS (P2,598,295.55)** or such other sums as may be ascertained, **BALBALIN ENGINEERING AND CONSTRUCTION** agrees to execute the contract **"IMPROVEMENT OF COFFEE TRAINING CENTER"** in accordance with his/her/its Bid.
4. **BALBALIN ENGINEERING AND CONSTRUCTION** binds itself in behalf of the Entity to enable the performance of the warranty on all the laboratory equipment to be delivered under this Contract within the period provided and under the terms and conditions covering the same.
5. **BALBALIN ENGINEERING AND CONSTRUCTION** shall provide technical support relevant to the items delivered under this contract within the period officially provided under the terms and conditions of the laboratory equipment and likewise provide one (1) time on-line training to the end-users however, at the option and expense of the Entity, may send their end-users to the head office of the Supplier for hands-on training.
5. The **MOUNTAIN PROVINCE STATE POLYTECHNIC COLLEGE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

**IN WITNESS** whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
